

Scorpio Super Formula 2025 Scorpio Team Endurance Championship 2025

Terms & Conditions

1. Eligibility

- 1.1 Participants must be 16 years of age or older at the time of the event. Participants under the age of 18 must provide written consent from a parent or legal guardian.
- 1.2. Participants must possess a valid government-issued ID for age verification.
- 1.3. The event is open to all eligible participants worldwide; however, travel to and from any location associated with the prize is not covered by the event organizers or sponsors.
- 1.4. Any attempt to use fake identities, multiple accounts, or engage in fraudulent activities will result in immediate disqualification.
- 1.5. Participants must have access to a stable internet connection and a functioning racing setup (wheel, pedals, or controller). In an event of unstable connection which causes lag, or in case of the fault with the wheel or pedals, participants must ensure that other drivers are not impeded.

2. Event Rules and Conduct

- 2.1 Participants are required to adhere to the race league's rules and regulations, including fair play, sportsmanship, and respect for all other competitors and officials.
- 2.2 The main aim of the Scorpio SuperFormula Championship is to identify individuals who demonstrate the skills and professionalism required for potential participation in real-life motorsport activities. Racing etiquette and sportsmanship must be maintained at the highest level at all times. Any contact or unsportsmanlike behavior, including but not limited to reckless driving, abusive language, or intentional disruption of other competitors, will not be tolerated and may result in disqualification.
- 2.3. Decisions made by the league organizers or race officials are final and not subject to appeal.
- 2.4. Intentional blocking, weaving, brake-checking, or any form of dangerous driving that could disrupt the integrity of the race will result in penalties or disqualification at the discretion of the race officials.
- 2.5. The final standings of the championship will consist of the 15 best results during the season (2 drop scores). Any event, in which a participant was disqualified, will not count as a drop score.

2.6. All participants must be present in an official PSN Party Chat, organized by race host or any other event officials, during the duration of an event.

3. Prizes and Participant Selection

- 3.1. The top three competitors of the series will receive trophies as recognition of their performance.
- 3.2. In addition to the trophies, winners will have the opportunity to visit Scorpio Motorsport in the United Kingdom for a VIP weekend experience.
- 3.3. Activities during the weekend experience may include spending time with the engineering team, visiting a racetrack, or other activities determined by Scorpio Motorsport after the discussion with the winners. All activities are subject to Scorpio Motorsport's availability and discretion.
- 3.4. The event organizers and Scorpio Motorsport reserve the right to extend invitations not only to top-performing participants but to any other drivers they deem valid based on their assessment of skill, sportsmanship, or other factors. These invitations may include, but are not limited to, opportunities to work with Scorpio Motorsport on driving, engineering projects, or graphic design initiatives.
- 3.5. The weekend experience is non-transferable and cannot be exchanged for cash or substituted for other prizes. Travel, accommodation, and incidental expenses are the responsibility of the prize recipients.
- 3.6. Scorpio Motorsport reserves the right to introduce additional incentives or wildcard selections for participants who demonstrate exceptional skill, sportsmanship, or technical knowledge, even if they do not finish in the top positions.
- 3.7. The invitation to Scorpio Motorsport may include optional skill assessments or workshops for those interested in real-world racing careers, engineering, or media production within motorsport.

4. Supervision by Scorpio Motorsport

4.1. The Scorpio Motorsport team owner and head engineer will actively supervise the series and retain the authority to make independent decisions about participants' suitability for potential real-life opportunities. This supervision extends to evaluating participants for potential roles in driving, engineering, or creative contributions such as graphic design.

4.2. Their decisions are final and are made in alignment with the championship's goals of fostering talent for real-life motorsport involvement.

5. Participation Waiver

- 5.1. By participating in the event, competitors agree to release and hold harmless the organizers, sponsors, and affiliates from any claims, damages, injuries, or liabilities arising from their participation in the event or acceptance of any prize.
- 5.2. Participants may be required to sign an additional waiver or release form to claim their prize and attend the weekend experience.
- 5.3. Participants acknowledge that the event is a competitive esports environment, and any disputes regarding race results, technical issues, or penalties will be handled internally by the organizers and are not subject to external arbitration.

6. Travel and Logistics

- 6.1. Prize winners are solely responsible for arranging and covering the cost of travel to and from Scorpio Motorsport locations in the United Kingdom.
- 6.2. Scorpio Motorsport will coordinate the weekend activities with winners, but participants must ensure their availability and arrange their own accommodations if necessary.
- 6.3. Participants are responsible for securing the necessary travel documents, including visas, passports, or any other legal requirements for travel to the United Kingdom. Failure to obtain these documents will result in forfeiture of the prize.
- 6.4. If a selected participant cannot attend the VIP weekend experience due to personal or logistical reasons, Scorpio Motorsport reserves the right to offer the experience to another eligible participant.

7. Publicity and Media

- 7.1. By participating in the event, competitors consent to the use of their name, image, and likeness for promotional purposes related to the event, without additional compensation.
- 7.2. Winners agree to allow Scorpio Motorsport and the event organizers to capture photos and videos during the weekend experience for promotional use.

- 7.3. Participants agree that any footage, images, or media from the event may be used for commercial or promotional purposes by Scorpio Motorsport and Grove Street Racing without additional approvals.
- 7.4. Any participant who refuses to comply with media or promotional obligations as outlined may forfeit their prize or standing in the championship.

8. General Conditions

- 8.1. Event dates, prize details, and terms are subject to change at the discretion of the organizers.
- 8.2. The organizers reserve the right to cancel or modify the event for any reason, including but not limited to unforeseen circumstances, technical issues, or insufficient participation.
- 8.3. All personal information collected during registration will be handled in accordance with applicable data protection laws.

9. Legal Compliance

- 9.1. This event is subject to all applicable local, state, and national laws and regulations.
- 9.2. Any disputes arising from the event will be governed by the laws of [Jurisdiction, e.g., United Kingdom or your location], and participants consent to the exclusive jurisdiction of courts in that location.
